Monthly Fixed Refuse Charge: \$13.00 per month

**PROMPT PAYMENT OF BILLS**

A charge of 3% but not less than \$.50 will be added to bills not paid within 20 days from date of issuance. A late payment charge shall be applied only once to any given amount outstanding. This charge is applicable to all customers. The utility customer may be given a written notice no sooner than 20 days after the bill is issued and unless payment or satisfactory arrangement for payment is made within the next 20 days, service may be disconnected pursuant to the Wis. Adm. Code, section 113.

**RECONNECTION BILLING**

All customers whose service is disconnected in accordance with the disconnection rules as outlined in Wis. Admin. Code ch. PSC 113 shall be required to pay a reconnection charge. The charge shall be \$40.00 during regular office hours. After regular office hours the minimum reconnection charge of \$40.00 applies plus any overtime labor costs, not to exceed a total maximum charge of \$80.00.

**INSUFFICIENT FUND CHARGE**

A \$20.00 charge will be applied to the customer's account when a check rendered for utility service is returned for insufficient funds.
